Horse Sports are a dangerous recreational activity and horse can act in a sudden and unpredictable (changeable) way, especially if frightened or hurt.

There is a significant risk that serious **INJURY** or **DEATH** may result from horse sport activities. I knowingly and freely assume all such risks, both known and unknown, and **I VOLUNTARILY PARTICIPATE** at my **OWN RISK** and assume sole responsibility for any injury, death or property damage I may suffer that arises from my participation in horse sport activities.

I understand and acknowledge the dangers associated with the consumption of alcohol or any mind altering drugs before and during the activity and I take full responsibility for any injury, loss or damage associated with their consumption. I agree not to drink alcohol or take drugs prohibited by law before or during any horse sport activities.

I agree to follow the directions of any event organiser or official and that any misconduct or refusal by me to follow any direction of any organiser of official can result in the **CANCELLATION** of my participation in activities and my immediate removal from my horse **NO MATTER** where that may occur. I understand that any such non-compliance may result in injury death and/or permanent disability as a result of my failure to comply.

I agree to wear a helmet at all times whilst participating in the sport where this is required under the relevant EA and FEI rules and

regulations, and agree that I am solely responsible for ensuring that whilst participating I wear a suitable helmet at all times and I take sole responsibility for my actions.

I have had sufficient opportunity to read this assumption of risk agreement, fully understand its terms and sign it freely and voluntarily.

By signing this disclaimer I hereby agree to accept full responsibility for the care and any costs incurred in looking after my horse/s should a Lockdown happen. Under no circumstances will I hold Goulburn Dressage Club Inc., or any of its Members, Committee Members or Office bearers liable.
